### What is this type of insurance?

This is insurance for your home which can cover buildings, contents and items away from the home, if selected by you. Unless we say otherwise in your policy schedule you are covered for fire, storm, flood, escape of oil, escape of water, theft, subsidence, vandalism and falling trees or aerials.

### What is insured?

### What is not insured?

- ✗ Wear and tear is generally excluded, but does apply under certain sections.
- ✗ War, riot, revolution, acts of terrorism or any similar event
- ✗ Any deliberate acts by you or a member of your household.
- ✗ Failure of computers or mobile phone and electrical equipment.
- ✗ After your home has been unoccupied for 35 days or more, we will not provide cover for: theft, vandalism, accidental damage, money, escape of water, escape of oil, glass, or damage to frozen food

### Are there any restrictions on cover?

- ! You must pay the applicable excess (the first amount of each claim for loss or damage) for each claim. This excess is shown in the policy schedule.
- ! Valuables such as jewellery and works of art are subject to limits that can be found in the policy booklet
- ! Liability cover applies to valid claims in connection with the risk address only

### Where am I covered?

- ✓ Building and contents cover applies at the risk address declared in your policy schedule
- ✓ If you have extended cover for personal belongings and valuables this is covered up to 60 days worldwide



### What are my obligations?

You must answer any questions we may ask. The following obligations will apply at the start and for the duration of your insurance contract. You must also answer all questions asked accurately and honestly:

- You must make sure that your sum insured for buildings and contents is adequate. If you are unsure of your buildings sum insured, please refer to [www.scsi.ie](http://www.scsi.ie)
- You must pay your premium(s) on time and in full
- You must take all reasonable steps to keep the home in a good condition and take all reasonable steps to avoid loss or damage
- You must tell us at once about any change of circumstances which may affect your insurance, for example if your home becomes unoccupied, if you change address or if you make structural changes to your home
- As soon as you know about any loss, damage or accident you must contact us straightaway by calling 01 8022220 and provide us with all relevant information
- If the loss or damage was caused by attempted theft, theft or malicious damage you must notify An Garda Síochana immediately.



### When and how do I pay?

You can pay for your insurance in full when taking out the policy over the phone, online or through your broker (if applicable).



### When does the cover start and end?

The contract starts from the date selected by you. The start and end date of your policy will be outlined in your schedule. The term of the policy is 12 months unless otherwise agreed with us.



### How do I cancel the contract?

You can cancel the policy at any time by telling us in writing or over the telephone. To cancel the policy, just advise us by phone or in writing. We will refund premium on the following basis:

- ▶ If you request cancellation within 14 working days of the date upon which we inform you the policy has been incepted, we will refund the full premium.
- ▶ Otherwise, we will issue a refund based on the unused days left to run on the policy, provided no claims have been made on your policy. We will not refund your premium if you are paying it under an instalment scheme (unless you made an overpayment). We may cancel this policy by sending you ten days' notice in writing to your last known address. We will refund a percentage of your premium depending on the period of the policy left to run, provided you have made no claim.

### **Right of Withdrawal**

A Consumer has the right to withdraw from any Dolmen policy within 14 working days of the start date of the policy without penalty and without giving any reason. The right of withdrawal may be exercised by notice in writing to your intermediary, quoting your policy number. Should this right be exercised, Dolmen will refund the paid premium and cover will be withdrawn from the proposed inception date. If the cover is motor insurance, the premium cannot be refunded until the Certificate of Motor Insurance and Disc has been returned to your intermediary. In this case, a charge may be made for the period between the inception date and the date of return of the Certificate and Disc

### **Quotation Period**

All quotes given in respect of Dolmen products are valid for 30 days.

### **Period of insurance**

The period of insurance in respect of any policy held with Dolmen will be the period specified by Dolmen as such in the policy Schedule/Renewal notice, usually 12 months.

### **Main Characteristics of the Policy**

The main characteristics of your (the consumer's) insurance policy is as explained to you by your broker and as set out in your policy document. This document is given to you and / or is available on request from your intermediary. Cancellation In the majority of cases, both the insured and Dolmen are entitled to cancel the policy by notice in writing. If you wish to cancel your policy within the first 14 working days from inception (Cooling off period) you will receive a full refund of any monies paid, regardless of having a claim within that period. If you cancel during the first year, outside of the 14 working days, Insurers will issue a refund based on the unused days left to run on the policy (Pro Rata) provided the customer has not claimed or been involved in any incident likely to result in a claim during the current period of insurance. In the case of cancellation of motor insurance, you, the Customer must return your Certificate of Motor Insurance and Disc to Dolmen. Certain policies are, however, non-cancellable and reference should always be made to the applicable Dolmen policy for the precise terms applicable to the particular case.

Dolmen may cancel policies at any time by giving you, the Consumer, 7 days' notice by registered letter to your last known address.

### **Default**

- **you** understand what each section covers and does not cover;
- **you** understand **your** own duties under each section and under the insurance as a whole.

<b>Schedule</b>	The <b>schedule</b> is part of this insurance and contains details of <b>you</b> , the <b>premises</b> , the sums insured, the <b>period of insurance</b> and the sections of this insurance which apply.
<b>Endorsement</b>	A change in the terms and conditions of this insurance.
<b>Period of insurance</b>	The length of time for which this insurance is in force, as shown in the <b>schedule</b> and for which <b>you</b> have paid and <b>we</b> have accepted a premium.
<b>Standard construction</b>	Built of brick, stone or concrete and roofed with slates, tiles, asphalt, metal or concrete.

## General Conditions applicable to the whole of this insurance

Each **home** included under this insurance is considered to be covered as if separately insured.

### Your duties

1. **You** must take all reasonable steps to prevent loss, damage or an accident and keep the buildings in a good state of repair
2. This **policy** is based on the factual information **you** provided. These facts are represented by the answers you have given to questions **we** have asked and/or the **proposal form you** completed and/or the **statement of facts we** last issued. If any of these facts have changed **you** must let **us** know immediately otherwise cover may not operate
3. If **you** are not sure whether or not certain facts are important, please ask **us**. **We** have the right to accept or decline changes to **your policy** and **we** may charge an additional premium including an administration charge.

If **you** fail to comply with any of the above duties this insurance may become invalid.

### Cancellation clause

1. **We** can cancel this insurance by giving **you** 30 days' notice in writing. Any return premium due to **you** will depend on how long his insurance has been in force.
2. **You** can cancel the policy, just advise us by phone or in writing. **We** will refund premium on the following basis:  
If **you** request cancellation within 14 working days of the date upon which **we** inform **you** the policy has been incepted, **we** will refund the full premium.  
Otherwise, **we** will issue a refund based on the unused days left to run on the policy, provided no claims have been made on **your** policy. **We** will not refund **your** premium if **you** are paying it under an instalment scheme (unless **you** made an overpayment).



# General Exclusions applicable to the whole of this insurance

## a) Radioactive Contamination and Nuclear Assemblies Exclusion

1. loss or destruction of or damage to any property whatsoever, or any loss or expenses whatsoever resulting or arising there from or any consequential loss
2. any legal liability of whatsoever nature

directly or indirectly caused by or contributed to by or arising from:-

- i) ionising radiations or contamination by radioactivity from any nuclear fuel or from any nuclear waste from the combustion of nuclear fuel,
- ii) the radioactive, toxic, explosive or other hazardous properties of any explosive nuclear assembly or nuclear component thereof.

## b) War Exclusion

any loss or damage or liability directly or indirectly occasioned by, happening through or in consequence of war, invasion, acts of foreign enemies, hostilities (whether war be declared or not), civil war, rebellion, revolution, insurrection, military or usurped power, or confiscation or nationalisation or requisition or destruction of or damage to property by or under the order of any government or public or local authority.

## c) Date Change Clause

We will not pay for any equipment, integrated circuit, computer chip, computer software and any other computer related equipment which fails to recognise correctly the date change to the year 2000 or any other date change.

## d) Biological & Chemical Contamination

1. Loss or destruction of or damage to any property whatsoever, or an loss or expenses whatsoever resulting or arising therefrom or any consequential loss;
2. Any legal liability of whatsoever nature;
3. Death or injury to any person;

Directly or indirectly caused by or contributed to by or arising from Biological or Chemical contamination due to or arising from;

Terrorism; and/or steps taken to prevent, suppress, control or reduce the consequences of an actual attempted, threatened, suspected or perceived terrorism.

For the purposes of this exclusion 'terrorism' means any act(s) of any person(s) or organisation(s) involving:

The causing, occasioning or threatening of harm of whatever nature and by whatever means;

Putting the public or any section of the public in fear;

In circumstances in which it is reasonable to conclude that the purpose(s) of the person(s) or organisation(s) concerned are wholly or partly of a political, religious, ideological or similar nature.

## e) Electronic Data Exclusion Clause

We will not pay for

1. Loss or destruction of or damage to any property whatsoever, or any loss or expenses whatsoever resulting or arising therefrom or any consequential loss;
2. Any legal liability of whatsoever nature

Directly or indirectly caused by or contributed to by or arising from

Computer viruses, erasure or corruption of electronic data;

The failure of any equipment to correctly recognise the date or change of date;

For the purposes of this exclusion 'computer virus' means a corrupting instruction from an unauthorised source that propagates itself via a computer system or network.

## f) Existing and Deliberate Damage

We will not pay for loss or damage

- occurring before cover starts or arising from an event before cover starts
- caused deliberately by you or any member of your home
- due to consequential loss of any kind or description.

# Claims Conditions applicable to the whole of this insurance

## Your duties

In the event of a claim or possible claim under this insurance

1. **you** must notify **your insurance agent** as soon as reasonably possible giving full details of what has happened.
2. **you** must provide **your insurance agent** with written details of what has happened within 30 days and provide any other information **we** may reasonably require.
3. **you** must immediately forward to **your insurance agent**, if a claim for liability is made against **you**, any letter, claim, writ, summons or other legal document **you** receive.
4. **you** must inform the Gardai as soon as reasonably possible following malicious acts, violent disorder, riots or civil commotion, theft, attempted theft or lost property.
5. **you** must not admit liability or offer or agree to settle any claim without **our** written permission.

If **you** fail to comply with any of the above duties this insurance may become invalid.

## How we deal with your claim

### 1. Defence of claims

**We** may

- take full responsibility for conducting, defending or settling any claim in **your** name.
- take any action **we** consider necessary to enforce **your** rights or **our** rights under this insurance.

### 2. Other insurance

**We** will not pay any claim if any loss, damage or liability covered under this insurance is also covered wholly or in part under any other insurance except in respect of any excess beyond the amount which would have been covered under such other insurance had this insurance not been effected.

This clause does not apply to fatal injury (section two-J).

### 3. Fraudulent claims

If **you** or anyone acting for you:

- Makes a claim under the policy, knowing the claim is false or misleading; or
- Makes a claim for any loss or damage deliberately caused by you;
- In connection with a claim makes a statement to us or anyone acting on our behalf, knowing the statement is not true;
- In connection with a claim sends us or anyone acting on our behalf a document, knowing the document is false;

**We** may take one or more of these actions as well as our other rights:

- **We** will not pay the claim.
- **We** may avoid the policy with effect from the date of the fraudulent claim or fraudulent act
- **We** will not return your premium.

If you commit a fraudulent act on any other policy, then we may:

- cancel this policy
- consider letting the appropriate law enforcement authorities know about the circumstances.

### 4. Claims Retention

- **We** will not hold any retentions for claims less than €20,000.
- Where we agree to pay your claim and the settlement amount is greater than €20,000 but less than €40,000, **we** reserve the right to withhold up to 5% of the final payment until the repair, replacement or re-instatement works are completed and validated through the submission of a final invoice and (where required by AXA) a final inspection report.
- Where **we** agree to pay your claim and the settlement amount is €40,000 or more, **we** reserve the right to withhold up to 10% of the final payment until the repair, replacement or re-instatement works are completed and validated through the submission of a final invoice and (where required by AXA) a final inspection report.

  - **we** will not pay for the cost of replacing any undamaged article forming part of such pair or set.
  - **we** will not pay more than a proportion of the insured value of such pair or set.

**Your** sum insured

3. If the total value of unspecified items at the time of the loss or damage is more than **your** sum insured for such items, then **we** will only pay for a proportion of the claim. For example if **your** sum insured only represents one half of the total value of unspecified items **we** will only pay one half of the cost of repair or replacement. ##### **DOL0001 - MINIMUM SECURITY ENDORSEMENT**

*We will not pay for loss or damage by theft or attempted theft from the Property unless the under noted minimum protections are fitted:*

*External Doors: Fitted with a five lever mortice deadlock / or a deadlocking night latch / or key operated integral multi point locking system.*

*Sliding Patio Doors: Fitted with a key operated security lock.*

*Windows: Fitted with key operated security locks or other effective locking mechanism on all ground and accessible first floor windows (waived if alarm is installed).*

##### **DOL0006 – HOTEL & MOTEL ENDORSEMENT**

*This Insurance does not cover theft or disappearance of jewellery from hotel or motel rooms during your absence from such rooms unless kept in a locked hotel safe.*

##### **DOL0007 - THEFT LIMITATION ENDORSEMENT**

*This insurance does not cover theft or attempted theft other than as a result of violent or forcible entry or exit to or from the home.*

##### **DOL0021 - SUBSIDENCE, LANDSLIP OR HEAVE EXCLUSION ENDORSEMENT**

*This Insurance does not cover Subsidence or heave of the site upon which the buildings stand or landslip as shown in number 9 of sections one (buildings) and two (contents). Furthermore if this exclusion is applied cover in respect of Alternative Accommodation is excluded.*

##### **DOL0048 - FLOOD EXCLUSION ENDORSEMENT**

*The insurance excludes claims resulting from:*

*The escape of water from the normal confines of any natural or artificial watercourse, lake, reservoir canal, dam;*

*Inundation from the sea; or*

*Flood resulting from storm or any other peril other than escape of water from fixed water tanks, apparatus or pipes.*

**DOL0110 - YOUR BANK AND OR BUILDING SOCIETIES INTEREST ENDORSEMENT**

The rights of the bank or building society who provided your mortgage will not be affected by anything you do to increase the risk of loss or damage to the home provided that they were aware of such action. The bank or building society must write and tell us as soon as they become aware of extra premium which you will have to repay them

**DOL0144 – CHIMNEY CLAUSE**

It is a condition precedent that all chimneys and flues are kept in a good state of repair and cleaned once every 12 months (Insurers will require appropriate evidence in support). In the event of either a chimney or flue fire no payment will be made unless compliance with this condition precedent is met.

**DOL0145 - FLAT ROOF ENDORSEMENT**

This insurance excludes loss or damage caused by ingress of water unless as a result of an insured peril. It is further noted that the roof must be inspected every two years by a qualified builder or property surveyor and any defects brought to light by that inspection shall be repaired within 30 days of said inspection.

**DOL0154a – PERSONAL POSSESSIONS**

Valuations are required for items of jewellery/ watches over €3,000.

The original valuation must include -

- The clients name and address, which should match our policy record.
- The valuation must be from an E.U. company and in English Language.
- Value of the individual item(s) including a running total on each a page.
- Name and address of the valuer.
- The date valuation was carried out must be within last 12 months of policy inception  
Or being noted mid-terms and then every 5 years.
- a Full description of the item including details such as size, number and type of all main features.
- Model & Serial Number, particular with regards to prestige brands such as Rolex, Ebel, Patek etc.

If the valuation is not received after 30 days from notification of the claim, we reserved the right to refuse the claim.

**DOL0165 - SETTINGS & MOUNTINGS CLAUSE (2)**

It is a condition that all jewellery / watches valued €10,000 and over are inspected at least once every 2 years by a qualified professional jeweller and any defects immediately rectified and a receipt of the inspection obtained.

**DOL0166 - ALARM CLAUSE**

This insurance does not cover theft or damage as a result of theft or attempted theft when you have left the premises without an authorised occupant unless:

- a) at all such time the intruder alarm has been put into full and effective operation.
- b) the intruder alarm provides protection to all external doors and accessible windows.
- c) the intruder alarm is to EN 50131 (IS199) standard and is kept in full working order and fully maintained (including its methods of signalling) throughout the period of insurance.

**DOL0171 – RIDE ON LAWNMOWER CLAUSE**

It is hereby noted and agreed that this insurance excludes theft of the ride on lawnmower specified in the schedule of insurance whilst in the open and must be kept locked to an immovable object whilst in a locked outbuilding.

**DOL0203 - RENOVATED CONDITION**

It is a condition precedent that any property built prior to 1920 must have undergone a full refurbishment (rewired, replumbed and re-roofed) since 1970 as stated in the policy statement of fact. In the event of a loss arising under the policy no payment will be made unless this condition precedent has been met.

**Notice to the insured**

The parties are free to choose the law applicable to this Insurance Contract. Unless specifically agreed to the contrary this insurance shall be subject to Irish Law.

## Right of Withdrawal

The right of withdrawal may be exercised by notice in writing to your intermediary, quoting your policy number. Should this right be exercised, Dolmen will refund the paid premium and cover will be withdrawn from the proposed inception date. If the cover is motor insurance, the premium cannot be refunded until the Certificate of Motor Insurance and Disc has been returned to your intermediary.
